Conditions for the Validity of Fire Safety Certificate (NOC).

- 1. All the fire safety and means of escape facilities shall be maintained in good working conditions at all time. Any lapse rendering fire safety or means of evacuation facilities rendering non-functional shall be the responsibility of the management.
- 2. There should not be any change of Trade for which this License has been issued.
- 3. Building sanctioning authority may verify any deviation with regard to the construction/ occupancy in the building. In case of any deviation, the Fire Safety Certificate stands null and void.
- 4. Water reservoir should always be kept full up to brim.
- 5. The entrance and exit and the water reservoir should always be free from any obstruction/ projection.
- 6. The staffs shall be trained for operating fire fighting system and mock evacuation drills be conducted at regular intervals and record be maintained.
- NB:- This Fire Safety Certificate is issued subject to the condition that the applicant shall be liable at all times to strictly adhere to the relevant legal provisions of the Tripura Fire and Emergency Services Act, 2022, the Tripura Building Rules, 2017, the National Building Code of India, 2016, and the TLR & LR Act, 1960, pertaining to the premises (involving 2687.7 sqm. covered area) for which this Fire Safety Certificate (Fire NOC) is issued, failing which it shall be liable for cancellation.
